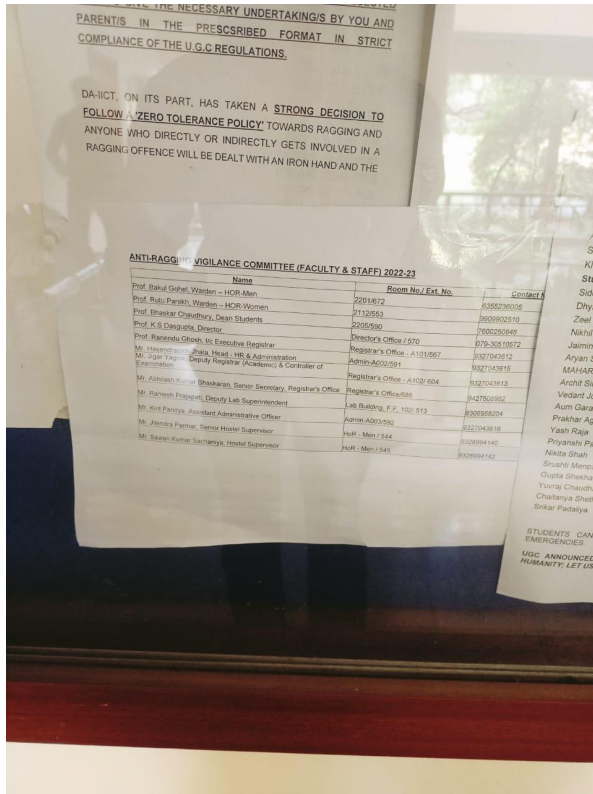

AS YOU ARE VERY MUCH AWARE, RAGGING IS A CRIMINAL OFFENCE. YOU ARE REQUESTED THEN TO GIVE THE NECESSARY UNDERTAKING/S BY YOU AND PARENT/S IN THE PRESCRIBED FORMAT IN STRICT COMPLIANCE OF THE U.G.C REGULATIONS.
